

# Introduction

Reviewing legislation, policies and other interventions at their design phase for their potential impacts in rural communities is known as rural proofing or applying a 'rural lens'. If negative impacts on rural areas are possible, the intervention should be adapted to ensure they do not happen.

Some countries have been rural proofing for decades, but there is mixed evidence of success. The Scottish Government made a commitment to apply a rural lens to National Strategy for Economic Transformation (NSET) projects in late 2022. All policies will be rural proofed through the forthcoming Rural Delivery Plan.

# Methods

- Desk-based work and interviews in 'Reimagined policy futures: Shaping inclusive, sustainable and just rural and island communities in Scotland (ReRIC)' reviewed the evolution of rural and island policy in Scotland since 1945.
- A SEFARI Specialist Advisory Group advised the Scottish Government on implementing a rural lens across policy areas.
- Linked work with the European Network for Rural Development (ENRD) and the EU's Rural Pact informed the implementation of rural proofing across EU member states and regions.
- Work with El Hueco and Cives Mundi informed rural proofing in Castilla-La Mancha, Spain.

# Results

- Many issues have repeatedly featured in Scotland's rural policies and strategies in recent decades (e.g. affordable housing, service provision, transport and digital connectivity, etc.).
- Limited if any (publicly-available) evaluation of, and learning from, previous interventions.
- Commitment to rural proof NSET projects in 2022 represented a shift in approach to rural policy in Scotland.
- Scottish Government launched Rural Assessment Toolkit (internally) in Spring 2025; Rural Delivery Plan to be published soon.
- Commitment for EU member states to rural proof in the European Commission's 'Long term vision for rural areas' (2021).
- Some regional level rural proofing, e.g. in Castilla-La Mancha, where rural proofing is connected with tackling long term depopulation.
- Recent attempts in England, Ireland and Canada to reinvigorate rural proofing, Northern Ireland remains only country to have legislated for it, proved hard to achieve well elsewhere. Evidence of 'success' is mixed (even limited).
- Island proofing (through Island Communities Impact Assessments) is a legislative requirement in Scotland, but applying the Rural Assessment Toolkit is voluntary.

- What role should researchers play in rural proofing?









